X-Scooter Rental Terms and Conditions

1. By signing this form, you accept all terms and conditions outlined in this rental agreement. Please read this document carefully and let us know if you have any questions.
2. The term "X-Scooter" refers to all makes and models of X-Scooter we supply for hire. This includes, but is not limited to, X-Scooter Sierra, X-Scooter Cuda and X-Scooter CSI.
3. The deposit and rental fees must be paid in full prior to the collection of the X-Scooter and accessories. The deposit will be refunded after the return of the X-Scooter in accordance with these terms and conditions. Breach of these terms and conditions will result in the deposit being held by Deep Ideas Ltd until all outstanding charges have been paid in full.
4. The X-Scooter and accessories remain the property of Deep Ideas Ltd. We may ask for its return at any point in the rental period. The X-Scooter and accessories must be returned within 24 hours of any such request.
5. The rental period will be agreed before collection of the X-Scooter. Failure to return the X-Scooter and accessories by the designated date/time to the agreed location will incur a charge equivalent to the daily rate for every day or part day the X-Scooter or accessories are overdue. If the X-Scooter or accessories are overdue for more than 2 days without our permission we will commence legal action against you to obtain the immediate return of the X-Scooter and accessories.
6. The X-Scooter and accessories are deemed to be in your possession until they have been handed to and checked by a member of Deep Ideas Ltd.
7. We do not provide insurance cover for loss or damage to the X-Scooter or accessories. You may arrange your own insurance to cover the X-Scooter and accessories during the rental period.
8. If the X-Scooter or accessories are stolen or damaged (other than normal wear and tear) you are responsible for compensating Deep Ideas Ltd for the full replacement or repair value of the X-Scooter and accessories (even if this is not your fault). You are financially responsible for any costs incurred arising from any insurance claim you make or any claim made by a third party.
9. You must not sell, rent or dispose of the X-Scooter and accessories or any of its constituent parts.
10. You must not attempt to fix or modify the X-Scooter or accessories in any way, nor allow any third party to attempt to fix or modify the X-Scooter or accessories with the exception of Deep Ideas Ltd. Deep Ideas may provide directions and/or components for you to repair the X-Scooter, or arrange a field repair on the behalf of Deep Ideas Ltd, this will not violate this agreement.
11. You must not attempt to disassemble the electronics or battery packs in any way. All batteries are potentially very dangerous and may cause bodily harm and/or fire if tampered with.
12. You must inform us as soon as possible if the X-Scooter or accessories develop a fault. All X-Scooters and accessories will be thoroughly checked before collection by Deep Ideas Ltd.
13. You agree to return the X-Scooter and accessories in the condition it was supplied to you (normal wear and tear excepted).
14. We are not responsible for any direct or indirect losses as a result of loss, damage or failure of the X-Scooter or accessories.

15. The X-Scooter and accessories must only be used by you, the named renter. The named renter is responsible for any loss or damage to the X-Scooter or accessories and/or any claims as outlined in (5.). The renter is responsible for all charges described in these terms and conditions. The renter is also responsible for any charges resulting from failure to abide by the terms and conditions.
16. You must not use the X-Scooter or accessories whilst under the influence of alcohol or drugs.
17. You must obtain written permission from Deep Ideas Ltd before taking the X-Scooter or accessories outside of England, Scotland or Wales.
18. You are responsible for any charges arising from Customs and Excise or Immigration Authorities seizing the X-Scooter or accessories.
19. Interest will be added every day to any amount you do not pay on time. The rate of interest will be equivalent to the base bank lending rate.
20. This agreement will come to an end when you return the X-Scooter and accessories to a member of Deep Ideas Ltd in accordance to these terms and conditions. We will terminate this agreement immediately if we find that your belongings have been removed to payoff debts or if any Receiving Order has been made against you. We will also terminate the agreement if you fail to meet all conditions described within this agreement. If we terminate this agreement it will not affect our rights to receive any money owed under the terms and conditions of this agreement. We can also claim any additional costs we may incur as a result of your breach of the terms and conditions of this agreement. We can repossess the X-Scooter and accessories from you and you agree that we may enter such parts of your property to retrieve the X-Scooter and accessories provided force is not used nor damage caused to your property.
